

Preserve 2020 and 2021 Virginia Election Data!

I know many Virginians have concerns about elections beginning in 2020 and about the integrity and transparency of the election that begins on September 23, 2022. If you follow the election Virginia integrity and transparency topic you, like me, may have come to think about this as an Election *Insecurity* and *Obscurity* system.

Or you may have been convinced that while the Virginia Election System is not perfect, it is not systemically corrupt and there is no evidence that any corruption or fraud would not have overturned any 2020 or 2021 election. In either case you deserve to know for sure and to be confident and proud of our Commonwealth's Election System.

One of the issues citizens face is that the system is opaque. They cannot get the data, the Cast Vote Records, and inside the digital storage and manipulation of election data. The system appears to be designed to be complicated and no one really seems to know what happens to your vote once it is translated into ones and zeros.

So, citizens cannot analyze the data and records and therefore cannot document the issues that led to numerous anomalies and irregularities reported to date. A senior Attorney in the Attorney General's Office has argued, the Office of the AG "...has not seen any evidence of widespread fraud that would change the results of Virginia's 2020 election. Therefore, we have no justification [to] commence a proceeding to stop the discarding of the ballots this year." See Email chain here.
